Mutual Exchange guidance notes

Before completing the exchange application form please read the following information.

Reasons an application for mutual exchange will be rejected

Disabled adaptations

Exchanges will not be permitted where one party is seeking to occupy a property adapted for a disabled person, unless another disabled person, requiring the same adaptations will be in occupation upon completion of the exchange.

Over 55's accommodation

Exchanges will not be permitted for over 55's accommodation unless the new occupants also meet the minimum age criteria of 55.

Like for Like

Exchanges will not be permitted where a like-for-like exchange request is received (i.e. where a tenant already occupies the same property type as that which they are requesting to exchange into) unless there is an exceptional circumstance which requires a move. These will be considered on a case by case basis.

Overcrowding / Under Occupying

Exchanges will not be permitted if overcrowding or under occupying by more than one bedroom will occur on the basis of the sleeping arrangements. This is in line with property entitlement, see table on next page.

Alterations to current property

If you have made any alterations to your property (other than internal decoration) without requesting permission your exchange will not be agreed. Please go to www.newportcityhomes.com and retrospectively apply for permission for your alteration. Permission must be granted before you can apply for an exchange.

Debt

Exchanges will not be allowed where there is outstanding housing debt owed to Newport City Homes. Debt should be cleared before completing the application form. Exceptional circumstances with outstanding debt will be considered on a case by case basis.

Tenure

An exchange will not be allowed whilst you hold an Assured Shorthold Tenancy.

Notice of Seeking Possession

An exchange will not be allowed whilst you are subject to a valid Notice of Seeking Possession.

What you are required to do before the exchange happens

Rent in advance

At the point of signing for the exchange you will be required to pay the first week's rent in advance. Please check with Newport City Homes as to the amount of rent for the property type you are interested in.

Viewing

You are required to view the property that you are interested in so that you are aware of the internal as well as external appearance and layout. Signing the exchange application form is confirmation that you have visited the property and viewed it.

Property entitlement

Please read the following information as it will help you to decide if you are eligible for the size and type of property that you wish to exchange into.

This information is for guidance only and does not guarantee that permission to exchange properties will be automatically granted upon submission of your application form.
